## ADDITIONAL TERMS AND CONDITIONS

1. **Seller's warranties.** Seller has developed the pre-license training program to provide assistance to individuals applying for a state insurance producer license. While the program materials include valuable information to provide assistance in connection with the licensure process, Seller makes no representations or warranties regarding the likelihood that Buyer will obtain licensure by the state department of insurance. Seller agrees, for a period of ninety days following purchase, to replace the videotape(s) in the event on any manufacturing defects which render the videotape(s) inoperable.

2. **Buyer's obligations.** Buyer acknowledges that Seller has expended considerable time, effort and money in developing the training program reflected in the program materials. Buyer agrees that he will not make copies of otherwise reproduce any portion of the program materials. Buyer further agrees that he will not use or attempt to use, either directly or indirectly, all or any portion of the program materials for any purpose other than Buyer's individual use and that Buyer will not use all or any portion of the program materials for Buyer's profit.

### 3. **Miscellaneous.**

A. **Choice of Law/Venue.** This Agreement shall be interpreted in accordance with the laws of the state of Illinois. In the event of any dispute between the parties, the parties agree to submit to the jurisdiction of the courts of the state of Illinois. The parties further agree that proper venue for any action shall lie and be within Peoria County, Illinois.

B. **Invalidity.** In the event a Court determines that any of the provisions of this Agreement are invalid, such determination shall not affect the validity of the remainder of the provisions of the Agreement.

C. **Entirety of Agreement.** This Agreement contains the entire agreement between the parties and no oral representation, warranty or covenant exists. This Agreement supercedes and nullifies any agreement (or offer or counteroffer) as may have been given or entered into by the parties prior to the date of the acceptance hereof.

D. **Captions/gender.** The captions contained in this Agreement are included for convenience only and do not control the agreement of the parties. The use of the masculine gender is intended to apply to both males and females.

E. **Enforceability.** A facsimile or e-mail version of this Agreement shall be enforced to the same extent as an original copy of the Agreement.
